LGIC Marketing Pvt. Ltd. The party No.1 is the Offeror hereinafter being referred as the franchise dealer. The agreement made between the two parties regarding the Franchise dealership by the offeror LGIC Marketing Pvt. Ltd. (Parent Company) to the acceptor through its authorised representative is the acceptor that is franchise dealer on the following terms and conditions as enumerated below.

1) That the franchise dealership is regarding the sale of gold coins and jewelleries provided by the parent company LGIC Marketing Pvt. Ltd. Who is the Franchise dealer will function according to the policy and procedures as laid down by the parent company.

2) As per the policy and procedure of the parent company, the transaction includes four packages. Package No. 1 consists of Jewellery worth 100 gm of gold in weight. The franchise dealer will have the right to sale or inviting booking for investment with the implicit consent of the parent company.

3) As per the Policy/Procedure of the parent company Transaction includes four packages. Package No.1 consists of dealing in gold coins or gold jewellery worth 100 gm. in weight & package No. 2 consist of gold coin or gold jewellery worth of 200 gm. in weight. and package No.3 consist of Gold coin worth of 300 gm in weight and package No. 4 Consist of Gold coin worth of 400 gm in weight.

4) The franchise dealer shall have deposit Rs. 5,999/- for booking of **package no.1 Primary Golden Table**, similarly booking deposit for **package No.2 Standard Golden Table** is Rs. 10,999/- . This is one time deposit. The booking deposit money is not refundable at the time of termination of the contract. And for the **package no. 3 Star Golden Table** is Rs, 50,999/-. And the franchise shall have to deposit Rs. 1,20,999/- for booking package no 4 **Loyal Golden Table**.

5) The Franchise Dealer has to carry out trade, regularly and with consistency. He/She can do it individually or through teamwork by involving unemployed persons thus creating employment opportunities. Franchise Dealership will not be allotted unless the booking amount and agreement cost are paid.

6) The price of gold used us to varies according to fluctuation rates in International market & according to dealers commission will be changed accordingly. Incentives and bonus on transactions of package no.1 as company as well as package no.2, Package no.3 and Package no.4 as determined by LGIC Company as per norms fixed for the purpose.

7) In case of breach of any clause of this agreement/termination of the contract by the franchise dealer unilaterally. The deposits money for package no.1 or package no. 2, 3 and 4 will not be refunded.

8) The franchise dealer shall have to accept and act according to changes made in Business strategy Marketing Plan and Legal provisions by the parent company namely LGIC marketing Pvt. Ltd. from time to time.

9) The final termination of this contract shall be made with the mutual consent without any loss to any of the parties involved in this contract and will be done amicably and peacefully. Any act of the franchise dealer that amount to breach of any clause of this agreement or of criminal nature or breach of trust may entail termination of this agreement/contract by the parent company that is LGIC Marketing Pvt. Ltd.

10) As per company's schedule and norms project no 1 and project no 2 which consist of package no 1 (Namely **Primary Golden Table**) and package no 2 (Namely **Standard Golden Table**) are lucrative and potential Creator. Also project no 2 consist of package no.3 and 4 which renders good chunk of amount to users of every packages.
